WHEREAS, the President of the United States issued Homeland Security Presidential Directive 5 (HSPD-5) which directed the Department of Homeland Security, in cooperation with representatives of federal, state, and local government, to develop a National Incident Management System (NIMS) to provide a consistent approach to the effective management of situations involving natural disasters, man-made disasters or terrorist attacks; and

WHEREAS, the NIMS provides a consistent nationwide framework and approach to enable government at all levels, the private sector, and nongovernmental organizations to work together to prepare for, prevent, respond to, recover from, and mitigate the effects of incidents regardless of the incident's cause, size, location, or complexity; and,

WHEREAS, the HSPD-5 requires that state and local governments adopt the NIMS as a pre-condition to the receipt of federal grants, contract and activities related to the management and preparedness for certain disaster and hazard situations; and

WHEREAS, the Governor of the State of Texas declared NIMS as the standard for incident management in Texas; and

WHEREAS, the Counties and Cities having jurisdiction within the Port of Corpus Christi Authority's Area of Responsibility have adopted and implemented the NIMS; and

WHEREAS, the Port of Corpus Christi Authority adopted the NIMS on September 13, 2005, and desires to ensure a coordinated incident response and to maintain compliance with applicable local, state and federal requirements;

NOW THEREFORE BE IT RESOLVED BY THE PORT COMMISSION OF THE PORT OF CORPUS CHRISTI AUTHORITY OF NUECES COUNTY, TEXAS, THAT:

<u>Section 1</u>. The Port Commission hereby supports the full institutionalization of the National Incident Management System throughout all applicable organizational processes and encourages continued implementation from our private sector partners.

<u>Section 2.</u> This Resolution is hereby adopted by the Port Commission on January 17, 2017.

LIABILITY FOR DAMAGE TO PORT AUTHORITY PROPERTY

When damage is caused to any of the property or any of the facilities of the Port Authority, the Users causing such damage (including, without limitation, said Users' agents, servants, representatives, and employees as defined in Item 100) shall be held jointly and severally responsible for the cost of repairs, and they shall be billed thereto, and all shall be jointly and severally responsible for payment thereof. One or more invoices may be rendered to Users as costs are incurred, and said costs may include invoices from third parties as well as direct costs (including, without limitation, labor) of the Port Authority. All invoices shall include an override of 20% for Port Authority overhead. All invoices shall be paid within 30 days. When the damage is caused by a Vessel, the Port Authority shall be able to detain the Vessel until it has received a satisfactory guarantee for either the amount of the damage or for a reasonable estimate thereof.

In the event any of the invoices referred to above are not paid within 30 days, then the User (including, without limitation, Vessel owner or operator or any agent thereof), shall be liable for all legal costs and expenses of collection, including reasonable attorneys' fees, and including the costs of arresting and proceeding in rem against a Vessel.

If damage is caused to any Terminal Facility or other property of the Port Authority, the User to whom such Terminal Facility or other property has been assigned must make a written report of the occurrence to the Authority's Executive Director, including the date and time the damage occurred, a description thereof, the names, addresses and business connections of such User, and the parties, or persons causing such damage, as well as the names, addresses, and business connections of witnesses to the occurrence, and all other available pertinent facts and information with respect thereto. Such report shall be made within 48-hours following the occurrence that causes the damage; however, a verbal report shall be made immediately to the Harbormaster.

















La Quinta Gateway Terminal Buffer Area Noise Model Status – voestalpine and Cheniere











Approve Payment of United Corpus Christi Chamber of Commerce 2016 Invoice in the amount of \$75,000 for the South Texas Military Facilities Task Force

<u>SUMMARY</u>: On December 15, 2015, the Port Commission approved a Resolution Funding the Port of Corpus Christi Promotion and Development Fund for 2016 and Matters Related Thereto ("PDF Resolution") authorizing the Executive Director to pay the Business/Community Development expenditures included in PCCA's 2016 Annual Budget. One of the budgeted expenditures was \$75,000 for the South Texas Military Task Force ("STMTF"). The United Corpus Christi Chamber of Commerce, acting on behalf of the STMTF, submitted an invoice to PCCA for \$75,000 on October 20, 2016. This was PCCA's share of STMTF's budget for 2016.

Arguably, the PDF Resolution provides sufficient authority for the Executive Director to pay the Chamber's invoice without further action by the Commission. It is not PCCA's practice, however to make payments in excess of \$50,000 without express authorization from the Commission. Therefore, staff is requesting Commission authorization to pay the Chamber's 2016 invoice in the amount of \$75,000 for the STMTF.

BACKGROUND: The United Corpus Christi Chamber of Commerce (formerly the Corpus Christi Chamber of Commerce) has protected and supported the military facilities in this region through its South Texas Military Task Force. The STMTF was reinstated in 2012 after having been inactive since the 2005 BRAC decisions. The STMTF's goal is to protect the breadth and mission of the Corpus Christi Naval Air Station, Naval Air Station Kingsville, and the Corpus Christi Army Depot. These facilities are responsible for approximately 10,000 skilled direct jobs in this area and provide services to over 30,000 military veterans and retirees in the Coastal Bend. Because of the strong military presence in the Coastal Bend, the Port of Corpus Christi is designated as a strategic deployment seaport for U.S. military forces.

PORTS® is a NOAA program that supports safe and costefficient navigation by providing shipmasters, pilots, and other users with the accurate real-time information required for safe vessel loading and transit, and to avoid groundings and collisions. The MOA is a data sharing agreement which would allow CO-OPS to collect, quality control and disseminate data from new oceanographic sensors in the Corpus Christi waterways. As part of the MOA, PCCA is responsible for contracting with a NOAA-approved contractor to purchase, test, install, manage, operate, and maintain the equipment identified in the MOA as part of CC PORTS®. Texas A&M University -Corpus Christi's Conrad Blucher Institute for Surveying and Science (CBI) is a NOAAapproved contractor. Staff is currently negotiating an Interlocal Cooperation Contract with Texas A&M University - Corpus Christi's Conrad Blucher Institute for Surveying and Science (CBI) for Operation, Maintenance, Repair and Management of the Corpus Christi Physical Oceanographic Real-Time System (CC PORTS®). CBI is a NOAA-approved contractor.

I. PARTIES AND PURPOSE

- A. This Agreement is between the National Oceanic and Atmospheric Administration (NOAA) National Ocean Service (NOS) Center for Operational Oceanographic Products and Services (CO-OPS) and the Port Corpus Christi Authority of Nueces County, Texas (PCCA). NOS and PCCA have a common interest in the safe navigation and environmental management of Corpus Christi waterway and in the collection, quality control (QC) and dissemination of oceanographic and meteorological (MET) data in near-real time that supports marine navigation.
 - B. The purpose of this Agreement is to establish a data sharing agreement to allow CO-OPS to collect, QC and disseminate data from new oceanographic sensors PCCA will install in the Corpus Christi waterway. PCCA agrees to install and maintain these new sensors to NOS/CO-OPS standards and NOS agrees to incorporate this new data as part of NOAA's Corpus Christi Physical Oceanographic Real-Time System (CC PORTS®). PORTS® is a NOS program that supports safe and cost-efficient navigation by providing shipmasters, pilots, and other users with the accurate real-time information required for safe vessel loading and transit, and to avoid groundings and collisions.

II. AUTHORITIES

- A. The legal authority for CO-OPS and PCCA to enter into this Agreement is the Coast and Geodetic Survey Act (CGSA), 33 U.S.C. § 883e, which authorizes the Secretary of Commerce to enter into cooperative agreements, or any other agreement, with, and to receive and expend funds made available by any state, or subdivision thereof, any federal agency, or any public or private organization, or individual for surveys and investigations authorized under § 883a et seq.
- B. The programmatic authority for CO-OPS to enter into this Agreement is the CGSA, 33 U.S.C. § 883a et seq., which authorizes the Secretary of Commerce to conduct hydrographic and topographic surveys and tide and current observations, and analysis and prediction of tide and current data.

III. BACKGROUND

PCCA intends to install new current meters along the Corpus Christi navigation channel. The main shipping channel coming in from the Gulf of Mexico requires a left turn shortly after entering and currents perpendicular to this turn from the intercoastal waterway make this a challenge. Likewise, a long stretch of the channel as you enter Corpus Christi Bay is hit by these cross currents as well. Bringing vessels through the navigation channel to port with these cross currents is extremely difficult, so having real-time current information from a NOAA PORTS® system is crucial for safe navigation.

IV. CORPUS CHRISTI (CC) PORTS®

The CC PORTS® consists of the following:

- A. Horizontally Mounted Current measurement system at two locations for the measurement of horizontal current profiles: 1) UTMSI HADCP (Port Aransas), 2) Occidental HADCP (Ingleside, TX) to be installed by PCCA to NOS/CO-OPS standards. Each system includes an Acoustic Doppler Current Profiler (ADCP) to measure currents, mounted on an I-beam and winch for easy maintenance. Data will be transmitted back to NOAA via an IP modem and a Geostationary Operational Environmental Satellite (GOES) transmitter.
- B. Buoy Mounted Current measurement system at Aransas Pass Channel LB 3
 Aids to Navigation (ATON) buoy for the measurement of vertical current profiles,
 to be installed by PCCA to NOS/CO-OPS standards. This system includes an
 Acoustic Doppler Current Profiler (ADCP) to measure currents, mounted on a
 U.S. Coast Guard ATON buoy via a clampartus for easy maintenance and
 removal. Data will be transmitted back to NOAA via an IP modem and GOES
 transmitter.
- C. Water level station data that are part of the existing NOAA network will be incorporated into CC PORTS[®] at no cost to the PCCA at three locations: 1) Aransas Pass, 2) Port Aransas and 3) USS Lexington. Each station includes primary and back-up water level sensors and a meteorological package consisting of an anemometer, air temperature, and barometric pressure sensors. Data is transmitted back to NOAA via an IP modem and GOES transmitter.
- D. Additional sensors may be added in the future upon agreement of both parties and shall be identified by an amendment to this Agreement.

V. RESPONSIBILITIES OF THE PARTIES

In general, CO-OPS is responsible for the collection, QC and dissemination of the CC PORTS® data.

- A. CO-OPS agrees to provide at no cost to PCCA:
 - 1. Technical consultation to assure that the system design, installation, operation, and maintenance of the PCCA sensors are in accordance with CO-OPS guidelines and standards (See Appendices A and B).
 - 2. Water level and meteorological data from existing NOAA stations in the region at: 1) Aransas Pass, 2) Port Aransas and 3) USS Lexington.
 - 3. A centralized Voice Data Response System (VDRS) located at CO-OPS Headquarters, Silver Spring, Maryland, with access provided via a toll-free number.

- 4. Real-time quality control of all CC PORTS[®] data in the form of a 24 hours per day/7 days per week Continuous Operational Real-Time Monitoring System (CORMS) operation. This activity will be staffed by personnel contracted by CO-OPS to ensure that the data disseminated meets CO-OPS's standards for safe navigation.
- 5. Communications costs associated with CORMS.
- 6. Software maintenance and enhancements (which may be developed by CO-OPS).
- 7. Recommendations for hardware and equipment upgrades.
- 8. Final approval of all changes, additions, modifications to the CC PORTS[®].

B. The PCCA shall provide at their expense:

- 1. Contracting with a CO-OPS approved contractor for the expertise required to purchase, test, install, manage, operate, and maintain the equipment identified in Sections IV. A and B. in accordance with CO-OPS standards (see Appendices A and B).
- 2. Funding for emergency repairs by a CO-OPS approved contractor to the equipment identified in Sections IV. A and B. in accordance with CO-OPS standards (see Appendices A and B). PCCA will provide funds for the necessary modules/components required for the repairs.
- 3. Transmission of the sensor data from the new sensors identified in Sections IV. A and B. to CO-OPS via approved communication modes for QC and dissemination.
- 4. A local site representative. PCCA's site representative is the contact listed in Section VII. The PCCA shall notify CO-OPS if a new site representative is designated.

VI. FUNDING, PAYMENT, AND REIMBURSEMENT ARRANGEMENTS

- A. There is no transfer of funds between the Parties under this Agreement.
- B. CO-OPS will monitor data quality and terminate dissemination of information when, in its sole discretion, the information quality approaches unacceptable limits.
- C. CO-OPS will not achieve full cost recovery for the services it is providing. Under 33 U.S.C. § 883e (2), CO-OPS's estimated annual benefit for this PORTS® exceeds CO-OPS's annual contribution for data quality control and dissemination infrastructure.

C. The Parties agree that if there is a change regarding the information in this section, the Party making the change will notify the other Party in writing of such change. This change does not require a formal amendment.

VIII. DURATION OF AGREEMENT, AMENDMENTS, OR TERMINATION

- A. This Agreement will become effective upon the signature of both of the approving officials of the respective organizations entering into this Agreement and will expire on April 30, 2022. The Agreement will be reviewed annually.
- B. This Agreement may be amended or modified at any time by the mutual written consent of the Parties. This Agreement may be terminated by either Party upon 120 days written notice to the other Party.

IX. RESOLUTION OF DISAGREEMENTS

Should disagreement arise as to the interpretation of the provisions of this Agreement, or amendments and/or revisions thereto that cannot be resolved at the operating level, the area(s) of disagreement will be stated in writing by each Party and presented to the other Party for consideration. If agreement on interpretation is not reached with 30 days CO-OPS shall forward the written presentation of the disagreement to respective higher officials for appropriate resolution.

X. OTHER TERMS AND CONDITIONS

- A. All responsibilities under this Agreement are subject to the availability of appropriated funds. CO-OPS participation in this Agreement is contingent on receipt of the Federal funding required to operate the CORMS. Should CO-OPS be required to terminate this Agreement, data quality control and dissemination would cease. Should funds fail to be available to PCCA, PCCA shall have the right, at its sole discretion, to terminate this Agreement.
- B. This Agreement in no way limits other government agencies (federal, state, and local), port authorities, companies involved in maritime commerce, commercial fishermen, recreational boaters and fishermen, researchers, and the general public from having access to CC PORTS[®] data through (1) telephone voice messaging and (2) the Internet.
- C. CO-OPS agrees to promptly consider and adjudicate any and all claims which arise out of work under this Agreement by CO-OPS or duly authorized representatives or contractors of CO-OPS and to pay for any damage or injury as may be required by Federal law. Such adjudication will be pursued under the Federal Torts Claim Act, 28 U.S.C. 2671 et seq. or other such Federal legal authority as may be pertinent. CO-OPS also agrees to consider and adjudicate any claims for damage or injury sustained by CO-OPS personnel in the performance of their official duties while doing the work under this agreement. Such adjudication will be made pursuant to the Federal Employees' Compensation Act, 5 U.S.C. 8101 et seq., or other such Federal legal authority as may be pertinent.
- D. This writing embodies the entire Agreement and understanding between the Parties hereto, and there are no other contracts or understandings, oral or written, between them with reference to the subject matter hereof that are not merged herein and superseded hereby. No alteration, change, or modification of the terms of this Agreement shall be valid unless made in writing and signed by both Parties hereto.
- E. Neither PCCA, nor any its officers, directors, employees, Port Commissioners, or contractors, shall be responsible for any injury, damage, or liability occurring by reason of any act or omission by CO-OPS under or in connection with any work performed by CO-OPS or its agents under this Agreement.

APPENDIX A

MANAGEMENT, OPERATION, MAINTENANCE, AND REPAIR OF THE CURRENT METER STATIONS IN CORPUS CHRISTI

INTRODUCTION

The science, technology, and operations included in PORTS® are leading edge, cover a very wide range, and will continue to present challenges in the ongoing management of the system. Development and implementation of PORTS® by CO-OPS requires the expertise of specialists in technical management, oceanography, engineering, and information systems. It includes knowledge of currents and circulation, water levels, instrumentation, communications, computers, voice response systems, data management, and field operations.

Although CC PORTS® is a continuation of previously deployed technology, the physical and geographical challenges unique to the Corpus Christi area require on-going system refinement and upgrading. System management, operation, maintenance, and repair (MOM&R) and the most appropriate documentation of these activities will require further refinement as additional experience is gained. Modification of the required activities described in this Appendix must be approved by CO-OPS. The modified requirement(s) must be stated in writing, signed by the CO-OPS PORTS® Program Manager, and attached to CO-OPS' and the PCCA copies of this Agreement.

Maintenance must be conducted both at the system level and at the component level, at intervals that vary from daily to every two years. For reliable operation of the system with less than five percent down time, and to ensure dissemination of quality assured data, PORTS[®] must be maintained rigorously by personnel with the required expertise.

MANAGEMENT AND OPERATION

The PCCA shall perform the following duties:

- Schedule maintenance activities and ensure that they are conducted according to specifications and minimize down time;
- · Obtain quick response support as required to minimize system down time;
- Manage support contracts (e.g. diving services, measurement subsystem maintenance, data acquisition and dissemination subsystem maintenance, instrument refurbishment and calibration); and
- Interact with CO-OPS, Coast Guard, other federal agencies, port authorities, ship pilots and masters, tug and tow operators, companies engaged in maritime commerce, environmental agencies, the general public, and others as required.

The CO-OPS-operated CORMS will conduct continuous system checks and will provide the PCCA the results from the checks. When problems are encountered with critical system

components, the PCCA or contractor shall respond within four (4) hours of receiving negative system check information to make arrangements for corrective actions. The PCCA or contractor shall equip a watchstander or other appropriate employee/contractor with a pager or other means of responding 24 hours per day, 365 days per year for this purpose. The PCCA shall designate a contact person and back-up contact persons responsible for responding to negative system check information and identify these individuals to CO-OPS upon the execution of this Agreement. The PCCA shall notify CO-OPS of any changes in contact or backup persons within one work day.

MAINTENANCE

The PCCA will coordinate all maintenance activities and participate in them as may be appropriate.

The routine operations, maintenance, and emergency maintenance of the ADCP current measurement system must also be carried out by individual(s) knowledgeable in the methods and procedures of CO-OPS. CO-OPS will train the PCCA in the maintenance, and operation of the ADCP systems, if necessary. Routine annual inspection and maintenance of the ADCP systems will be completed by the PCCA.

Daily

1) The PCCA Contractor shall monitor the various PORTS® data products issued by CO-OPS, to maintain knowledge of the products and the associated data. Further, the PCCA Contractor shall respond to all requests regarding instrument status, repair schedules, etc.

Two (2) - Month Service Interval

- 1) The PCCA Contractor shall inspect all above-water components of the station (e.g., instrument enclosures, locks, antennas, solar panels, batteries, desiccant, stands and mounts,; conduit, cables, connectors, and air pump system). Clean, repair, or replace components and consumables as necessary.
- 2) The PCCA Contractor shall raise the side-looking current meters, inspect and clean any fouling off of chain and sensor.
- 3) The PCCA Contractor shall examine and clean the DCP with a vacuum, including fans as necessary.

Six (6) - Month Service Interval

- 1) The PCCA Contractor shall perform the two (2) month service interval maintenance as well as the following:
- 2) The PCCA Contractor shall employ diver services to clean any fouling off of the underwater components of the horizontally mounted current meters to ensure proper chain movement.
- 3) Replace all buoy-mounted current meter systems with a complete replacement system. Batteries shall be replaced and the current meter and clamparatus shall be cleaned for

redeployment in the future.

Two (2) - Year Service Interval

- 1) The PCCA Contractor shall perform the two (2) month and six (6) month service interval maintenance as well as the following:
- 2) The PCCA Contractor shall replace all gel cell batteries in all DCPs and top side electronics with approved replacements, per CO-OPS Engineering Bulletin 10-002: Standardize Battery Type for CO-OPS Water Level and Meteorological Stations with Photovoltaic Charging Systems. The PCCA Contractor shall properly dispose of all old batteries.
- 3) The PCCA shall return current meters, both horizontal and buoy mounted, to manufacturer for calibration.

Unscheduled

Respond to system failures as required. Repairs and replacements as may be necessary to ensure system reliability and data quality shall be made.

Approve 3rd and Final Year Retainer to Morehead Dotts Rybak for Community
Awareness Campaign and Related Expenses

SUMMARY: Staff requests approval of \$25,000.00 retainer fee for the 3rd and final year of the Community Awareness Campaign contracted with Morehead Dotts Rybak in 2015 and \$155,000.00 in estimated media and ad expenses as approved in the 2017 PCCA budget.

BACKGROUND: In 2015, the Port contracted with Morehead Dotts Rybak to embark on a Positive Engagement Plan, referred to originally by the tagline of People Move Our Port and more recently identified as the Community Awareness Campaign. The goals of the campaign are to inform, educate and communicate with the community stakeholders on the economic and job creating impact the Port has on the entire region and create a platform where the community is able to engage with the Port, and the Port can be proactive in addressing community concerns both local and region wide. The contract retainer fee of \$25,000 per year for a three (3) year period results in a contractual aggregate in excess of the \$50,000 statutory limit. The 2017 budget included \$180,000 in estimated media and ad expense for the community awareness campaign which also requires commission authorization.

Authorize Staff to Use Alternate Contract Method of Design-Build for the Congressman Solomon P. Ortiz International Center Redevelopment Project.

<u>SUMMARY</u>: Staff requests Commission approval to use the design-build purchasing contract method for the proposed Congressman Solomon P. Ortiz International Center redevelopment project, which will allow the consolidation of PCCA functions and provide additional space for current and anticipated future staff and regional agency partners.

BACKGROUND: The PCCA is evaluating the design and construction of a new administration facility to replace aging buildings and to consolidate the PCCA staff and functions at a single location that will provide a modern, safe, and efficient work environment for staff. Locations near the Congressman Solomon P. Ortiz International Center and the 222 Power Street address are being evaluated. Staff is also assessing the use of Design-Build delivery methods for the design and construction of the new office facility. The design build methodology was initially developed to support delivery of commercial buildings and provides schedule and delivery advantages that would be beneficial to the PCCA for a project of this nature.

<u>ALTERNATIVES</u>: In following Commission direction, large Port projects are evaluated for design-build delivery over the traditional design-bid-build. The use of design-build delivery method is recommended to provide cost-effective, time-efficient delivery of a new office facility.

CONFORMITY TO PORT POLICY: The design-build project delivery method is an alternate purchasing method available for contracting as per Subchapter O, Chapter 60 of the Texas Water Code. This project is included in the 2017 Capital Budget and is consistent with the PCCA 2025 Strategic Plan, identified in Strategic Goal #7 – Grow Our People to Staff the Future to provide a modern, safe, and efficient work environment for Port staff.

Staff requests approval to purchase a 2017 Ford Transit-350 XL 15-SUMMARY: Passenger Van to be used primarily for Port tours. Staff will utilize one of the stateapproved purchasing programs known as the Buy Board Cooperative Purchasing Program (Buy Board) to purchase this fleet vehicle at a cost of \$34,054.00 plus a BuyBoard contract fee of \$400.00 for a total of \$34,454.00. Purchases through these alliances eliminates the open bid requirement because the competitive procurement process has been completed with the award of the master agreement. Buy Board purchases also include a cash rebate on purchases paid annually to PCCA. The PCCA's General Purchasing Guidelines allows for the purchase of cars, trucks, boats and other major mobile equipment directly from state or federally approved purchasing programs with Port Commission approval. Approve a Dredge Pipeline and Effluent Ditch Easement Agreement with the U.S. Army Corps of Engineers to Reconfigure a Portion the Suntide Dredge Material Placement Area Effluent Drainage Ditch Located West of the Viola Turning Basin

SUMMARY: Staff requests approval of a Dredge Pipeline and Effluent Ditch Easement Agreement with the U.S. Army Corps of Engineers to reconfigure a portion of the Suntide Dredge Material Placement Area effluent drainage ditch located west of the Viola Turning Basin.

BACKGROUND: The existing Suntide DMPA effluent ditch begins at the outfall of the Suntide Dredge Material Placement Area (DMPA), runs north to Carbon Plant Road, then turns southeast and discharges into the Viola Turning Basin. The existing ditch alignment generally runs through the middle of a ±10-acre tract of land located west of the Vulcan Construction Materials, LP lease site potentially hindering the future development of this property. PCCA staff have been working with the U.S. Army Corps of Engineers (USACE) to reconfigure the ditch to a more appropriate location to allow for future development in this area.

In July 2016, the USACE included an option to reconfigure the ditch in their Fiscal Year 2016 and 2017 operation and maintenance construction contract solicitation. The scope of work for the ditch work consists of relocating approximately 1,125 feet of the existing Suntide DMPA effluent ditch to the south and run it alongside the limit of port property (see attached map exhibit). The work also includes installing new box culverts and restoring the old ditch to pre-project conditions. At the September 20, 2016 Commission meeting, the Commission approved payment to the USACE in the amount of \$313,000 for the PCCA's 25% cost-share for USACE to reconfigure the Suntide Dredge Material Placement Area effluent drainage ditch.

Presently, the USACE has a right of way to construct, operate, and maintain the Suntide DMPA, effluent ditch, and pipelines by means of term easements, which were conveyed by the PCCA to the USACE. These easements will expire on August 27, 2022. While the USACE has requested new easements for these lands, which would include the revised location of the ditch, the new easements will not be completed in time to award the

Suntide Ditch Relocation option in the FY 2016/2017 contract. As an interim solution to accommodate the relocation of the new ditch, the USACE has agreed to accept a temporary 50-year term easement for the portion of the ditch that will be reconfigured.





Award Purchase Contracts to Shibata Fender Team (\$22,960), TEKMarine Systems LLC (\$21,325), Zalda Technology Corporation (\$18,800), and QuayQuip B.V. (\$23,938), the Lowest and Best Bidders Based on Bids Received on January 23, 2017, for the Purchase of Dock Fenders and Panels.

SUMMARY: Staff recommends the award of purchase contracts to Shibata Fender Team, TEKMarine Systems LLC, Zalda Technology Corporation, and QuayQuip B.V. for the purchase of Dock Fenders and Panels. On January 23, 2017, we received four responses to our Notice to Bidders (see Bid Tabulation) for six separate bid items.

BACKGROUND: The PCCA maintains an inventory of ship and barge dock fenders to ensure that damaged port waterfront facilities can be quickly and efficiently repaired and returned to service. Each year, staff reviews the current inventory and recommends a budget for additional components to maintain the PCCA's fender and panel stock.

Contract documents were prepared this year that include rubber extruded fenders used for general cargo docks and large rubber fender elements and UHMW faced steel fenders used primary on bulk liquid ship docks and Cargo Dock 8. See attached Exhibit.

Bidders were allowed to bid on one or more of six different bid items. Bid Items generally consisted of:

- Bid Item 1 Ten (10) Units of MV 1250 x 1000A Fender Element Bodies and Hardware



SUMMARY: Staff requests approval of the attached deductive Change Order in the amount of \$215,000 with Russell Marine LLC, for the Construction of Oil Dock 15 project to remove the barge access gangway from the contract.

BACKGROUND: On May 17, 2016, the Commission approved a lease agreement with Martin Operating Partnership, L.P. for the construction and operation of a new Oil Dock 15. The dock will be owned by the PCCA and, since NuStar Logistics recently acquired all of Martin's assets in the Port of Corpus Christi Inner Harbor including the lease agreement, the dock will be used exclusively by NuStar Logistics, L.P. Per the terms of the lease agreement, the PCCA is responsible for constructing the dock structure, slip, and loading / unloading equipment. On September 29, 2016, the Port Commission awarded the construction contract to Russell Marine, LLC in the amount of \$17,001,600 for the Oil Dock 15 project.

NuStar, since acquiring Martin, has been evaluating the construction at Oil Dock 15 and how best to integrate this new facility into their Corpus Christi operations. NuStar has determined that they would not be using Oil Dock 15 to load/unload inland barges; therefore, the barge access gangway included in the project to support Martin's proposed usage, is no longer required and Staff negotiated with Russell Marine to remove this item from the contract. Since the gangway had yet to be fabricated, Russell Marine has agreed to reduce the amount of the construction contract by \$215,000, as reflected in the attached Change Order. With this and previous Change Orders, the revised contract amount totals \$16,926,600.

Approve a Deductive Change Order in the Amount of \$61,850 with MAX Underground Construction LLC, for the Sam Rankin Street Improvements Project for Changes to the Railroad Crossings

SUMMARY: Staff requests approval of the attached deductive Change Order in the amount of \$61,850 to Max Underground Construction LLC, for work associated with the Sam Rankin Street Improvements construction contract.

BACKGROUND: On October 18, 2016, the Port Commission awarded a construction contract in the amount of \$1,312,799 to Max Underground Construction, LLC for the Sam Rankin Street Improvements project. Included in the contract was the installation of prefabricated concrete rail crossings at two locations crossing Sam Rankin Street. However, after reviewing the condition of the existing crossings and the performance of other rail crossings installed nearby, staff negotiated a change to the contract to delete the two concrete rail crossings and instead install Endurance railroad crossing panels at one of the crossings. Endurance panels are constructed with recycled material and cost less than precast concrete panels. Cost savings result in reducing the construction contract by \$61,850. With this and previous Change Orders, the revised contract would total \$1,233,170.







Approve Service Order No. 4 in the Amount of \$29,275 with Platinum Environmental Solutions, LLC, for Environmental Consulting Services Related to an Historical Release of Hydrocarbons to Soils and Groundwater at the PCCA La Quinta Property.

SUMMARY: Staff requests approval to issue Service Order No. 4 of Master Agreement No. 10-16 with Platinum Environmental Solutions, LLC to conduct environmental consulting services for a time and materials amount not-to-exceed \$29,275 related to an historical release of hydrocarbons to soil and groundwater at the La Quinta Property.

BACKGROUND: Impacted soils resulting from historical operations along the Rattlesnake Pipeline at the PCCA La Quinta Property were identified during construction of the laydown area by the lessee, Corpus Christi Liquifaction (CCL), in February 2016. Subsequent sampling activities conducted in March 2016 confirmed that impacts to the soil exceed protective concentration levels. Additional invasive sampling and analysis, conducted in September 2016 delineated the nature and extent of impacted soils and groundwater, and established a migration pathway. Preliminary notification has been made to the Railroad Commission of Texas (RRC) and the responsible party, Koch Pipeline. Additional work is necessary to determine if the groundwater plume is stable and not migrating and remediate the contamination in soil and groundwater to levels protective to human health and the environment.

In the meantime, CCL has planned construction of a natural gas pipeline through the delineated area. CCL will excavate, segregate and haul the contaminated soil from the site. RRC requires sampling of the walls and bottom of the excavation. Port staff have negotiated a service order with Platinum Environmental Solutions, LLC to conduct this sampling. In addition, the consultant has proposed to take advantage of the open excavation through the contaminated area and apply bioremediation agents to enhance and facilitate remediation in this area. This would be preliminary start only and a full remediation effort addressing the entire impacted area in soil and groundwater will still be

necessary following appropriate permitting and approval by the RRC. A map depicting the location of the contamination and the excavation related to the CCL construction is attached.



Pursuant to PCCA Master Agreement No. 10-16 between Port of Corpus Christi Authority of Nueces County, Texas ("PCCA") and Platinum Environmental Solutions, LLC ("ENVIRONMENTAL CONSULTANT"), ENVIRONMENTAL CONSULTANT will provide the Basic and Additional Services set forth in Exhibit A of Master Agreement No. 10-16 in accordance with any additions or deletions to the same or any Services different from those described in the said Exhibit A, in this Service Order. This Service Order modifies or amends PCCA Master Agreement No. 10-16, the provisions of which not specifically amended by this Service Order will remain in effect.

Description of Project:

In January 2016, during construction of a laydown area on the PCCA owned La Quinta Property leased to Corpus Christi Liquifaction, LLC, (CCL), hydrocarbon impacted soil was discovered in an excavation and subsequently sampled by the installation contractor. The analytical results of the sample indicated that concentrations of several chemicals of concern associated with a hydrocarbon release exceeded Protective Concentration Levels. In an effort to investigate the extent of the impact in the vicinity of the excavation, soil samples were collected and analyzed in March 2016 by RPS. The analytical results from that effort suggested that the hydrocarbon impacts extend to the groundwater and beyond the sample locations. Additional soil and groundwater sampling data collected in September 2016 delineated the full extent and nature of impacted soils and underlying groundwater. CCL is planning to install a natural gas pipeline through a portion of the delineated area and removing some of the impacted soil. Sidewall and bottom samples are required in the excavation prior to backfilling. The addition of bioremediation agents during the pipeline construction may also provide some benefits to jump start future remedial activities.





Below, please find an update on issues of interest to the Port. Also, please find a brief summary of those activities conducted by Berlanga Business Consultants on behalf of the Port:

The 85th legislative session kicked off on January 10th, some of the legislative priorities indicated by state leaders are school finance, child protective services, ethics reform, school choice, sanctuary cities, and "bathroom" laws.

In his State of the State speech, Gov. Greg Abbott cited four emergency items for the legislative session; banning sanctuary cities, CPS reforms, ethics reform, and Convention of States.

Glenn Hegar, Texas State Comptroller, released the final biennial revenue estimate for the 85th legislative session. The final estimate is \$104.9 billion, down from \$110 billion in the previous estimate. Hegar said the downturn in the oil and gas industry is responsible for the lowering of the estimate.

Speaker Joe Straus (R-San Antonio) was unanimously elected as Speaker of the House of Representatives. This will be Speaker's fifth time to serve as Speaker.

Lt. Governor Dan Patrick recently said he expects this session's \$4 to \$6 billion budget shortfall to be taken out of health care and education. Patrick said the two take up 90 percent of the budget and the Senate will find cuts in order to save money.

Sen. Jane Nelson (R-Flower Mound), Chair of the Senate Committee on Finance, filed Senate Bill 1. Nelson said SB 1, as filed, is a starting point. SB 1 cuts 1.5 percent from all state agencies, but exempts the Foundation Schools Program. The bill also adds \$260 million to Child Protective Services (CPS), \$800 million to border security, and \$2.65 billion to student enrollment growth. On the House side of the Capitol, the House budget plan slightly increases spending by less than 1 percent without raising taxes. Speaker Straus said the House budget plan will "keep overall spending low while making investments in

children and our future." The House plans to make cuts to administrative costs and discretionary programs across state agencies. The House and Senate appear to be \$8 billion apart on their respective budget plans, meaning the House may be looking to use funds from the Rainy Day Fund and the Senate is not.

The House and Senate budget proposals differ on a number of issues: they do agree on two: child welfare and transportation funding. Both proposals include \$260 million for CPS and a maximum of \$2.5 billion in excess tax funds if the state sales and use tax revenue hits \$28 billion.

Sen. Nelson created two new working groups, one to develop a new way to pay for public schools and a second to examine health care costs. The public school working group will be led by Sen. Larry Taylor (R-Friendswood), who also serves as chair of the Senate Education Committee. Taylor said the working group will start from scratch and consider every option.

Seana Willing will be the new executive director for the Texas Ethics Commission.

Governor Greg Abbott announced the reappointment of Charles Smith as executive commissioner of the Health and Human Services Commission.

Transition

The incoming administration's transition has stalled due to a number of reasons. First, the number of mid-level appointments has slowed dramatically in recent weeks. Second, Senate Democrats, responding to the demands of Democratic voters, have slowed the pace of confirmations. And finally, a number of unforced political errors has consumed an already small and insular White House staff. While we anticipate the pace of these appointments to quicken over the next few months, it is not inconceivable that we are still without an Assistant Secretary for Civil Works for some time.

To date, only five nominees have been confirmed:

- Secretary of State Rex Tillerson
- Secretary of Defense James Mattis
- Secretary of Homeland Security John Kelly
- UN Ambassador Nikki Haley
- Secretary of Transportation Elaine Chao

Despite a fractious political environment in the Senate, the other cabinet nominees should be confirmed shortly. We will also see some mid-level appointees announced in the coming month.

FY17 Budget

While no progress has been made on completing the FY17 appropriations process, both the House and Senate passed budget resolutions. This sets up a procedural framework that allows the Senate can pass legislation affecting revenues with 51 votes (unlike the typical 60 required for most legislation). Recent comments by congressional leaders suggest that they will use this process to

enact tax reform. We still believe that the FY17 appropriations process will be completed in April.

Infrastructure Package

While both Republicans and Democrats are publicly discussing an infrastructure package, the political and practical difficulties of passing such are becoming apparent. Attached please find an article from the Washington Post, quoting House Transportation Chairman Bill Shuster.

In the article, Shuster acknowledges that any package needs some sort of revenues to pay for it. Revenues into the Highway Trust Fund have been declining for 10 years and Congress has engaged in a fair amount of budget gimmickry to fill the gaps. Paying for current obligations has already proven difficult. Paying for a massive new infrastructure bill will require commensurate revenues, which creates political problems for a party suspicious of government spending.

House Republicans indicate they want to address infrastructure this summer, while Senate Republicans want to lead with a tax reform proposal to pay for an infrastructure bill.

Senate Democrats released a \$1 trillion infrastructure plan as a political messaging tool. The plan does not include any new programs for ports, but merely increases funding for current transportation programs.

Tax Reform Proposal

As noted, an infrastructure bill may be dependent on a tax reform bill. The House is proposing a border-adjusted tax, which is a tax that is applied to all domestic consumption and excludes any goods or services that are produced here, but consumed elsewhere. So essentially the costs any product made overseas could not be deducted from corporate taxes. Conversely, the profits from any product exported overseas would not be subject to any tax.

The Senate Finance Committee Chairman, Orrin Hatch, last week indicated that the Senate would develop its own tax reform proposal. This will delay any potential agreement and thus delay any infrastructure package.

DC Meetings with John LaRue

We helped prepare a fact sheet on the status of the Corpus Christi Ship Channel Improvement project for John LaRue's meetings on Capitol Hill. We met with staffers from the local delegation as well as relevant House and Senate Committees to brief them on the status of our disputes with the Army Corps/OMB.

channels to distribute the message. In 2017, many of the same mediums will be used, however the message may change and other tactics may be added to reach a targeted group of people, in various segments of the region.







1.1 Port of Corpus Christi

(a) Summary of activities

The month of January was slow and concerning. Most people expressed hopelessness and continued frustration with the Voluntary Real Estate Program's moratorium. Calls continued to be received from property owners asking when will they would receive offers. Other calls pertained to a rumor heard about the entire project being cancelled. The DRA team spent time counselling and consoling property owners and attempting to set the record straight that the Bridge project is not on hold only acquisition and relocation offers. DRA team members explained that all other work continues. Half of the property owners understood, the other half expressed anger and repeated conversations had previously, about the moratorium being yet another example of systematic racism targeted at the Hillcrest community.

Community outreach this month focused on dealing with eligibility verifications, assistance in title and family mediations, incoming calls, request for meetings, participation in the Martin Luther King Parade with residents of the community, and a Question and Answer arts and craft event for the parents and children of Hillcrest.

 an ongoing activity when initiated by the property owners. These
 services primarily consist of; explanation of the relocation process and
 the status of their property appraisals.

 None purchased to date. Only one (1) property owner has requested a restrictive covenant. No change from December.
- (f) Title work performed

 To date a total of 233 titles commitments have been ordered of which
 230 have been received and are under review.
- (g) Other services related to relocation of residents during reporting period Met with local real estate agents to gather information on the current real estate market. The DRA team continues to update the Comparable Housing Study for the "Comp Book" weekly.
- (h) Summary of Port's ROW Contractor Disadvantaged Business Enterprise (DBE) % Goal DRA is not aware of a DBE goal set for this project. However, it should be noted that DRA and one of its subcontractors are both certified DBE firms.

Although the moratorium on making offers to property owners of the Hillcrest community remained in effect, DRA continued to prepare acquisition packages for property owners, conducted relocation interviews with onsite owners, collected documents, searching for comparable housing and preparing relocation packages for on-site owner's whose property appraisals were approved by TxDOT.

As requests to participate in the voluntary program continued to arrive and as program eligibility was confirmed additional title reports and appraisals were requested. The total number of title commitments ordered to date is 233, of which 230 have been received and are under review. The number of appraisals ordered increased to 138 parcels, of which 136 have been completed and are under review. 93 have been approved by TXDOT.

Community Outreach focused on damage control and building better relationships with community members.

Community Outreach

1 event was conducted in the month of January.

* Q and A Super Kids Arts and Crafts a community event
On January 26th, a Q and A Super Kids Arts and Crafts community
workshop was held for the children of Hillcrest. This community engagement
tactic was geared to bring families, DRA team members and the Port

Executive together in a comfortable, creative and safe environment while informing parents on the status of their specific properties.

Throughout the moratorium, we have experienced a heightened level of outrage focused on all parties involved in the Hillcrest Washington Coles (Port) project. Our outreach event was purposed to get the focus off of the moratorium, by reinforcing our relationships with the people of Hillcrest to this end, staff spent time visiting our Hillcrest neighbors and showing up at other community events, restaurants, churches, etc..

In the month of January the DRA office had 75 visitors versus 46 in December. We collected eligibility documents from 17 property owners.

Acquisition

During the month of January, title curatives with 4 different title companies. (Stewart, Bay Area, San Jacinto and First American) was the focus of primary acquisition activity. We are continuing to follow up with title companies on Affidavit of Heirship Questionnaires, Affidavit of Heirships, Not Same Person Affidavits and so on, anything that will speed up the closing of the 138 parcels that are in the process of being approved by TxDOT. We are clearing many title issues before offers are made. (this would typically occur after the offers are made. We delivered numerous documents to all four title companies in an effort to clear title issues. Title curative plans were cleared for 147 parcels that only needed a few items. As we review the parcels that are among the 138 completed appraisals, we are scheduling meetings in homes and at the office to discuss all title problems. We discuss what needs to be done and how to move toward a complete resolution of their title problems big and small. We are involved in several meetings a week to discuss the progress and discuss with staff what needs to be done to move forward quicker.

We continued to work with all landowners (off-site and on-site) that come into the office on a regular basis. We spend time helping to combat their fear and assure them that acquisition and relocation program is a good opportunity and that all will be treated fairly.

Relocation

During the month of January relocation continues to meet and interview onsite owners whose properties are currently being appraised. The relocation team met with owners and answered questions regarding the status of their relocation benefits.

Relocation continues to search for available comparable housing to maintain the project comparable book. The comp book has now been updated and refreshed. At the end of January, there were 149 properties in the comp book. Listings are added weekly. The Relocation manager continues to meet with local real estate agents to discuss market trends. Real Estate agents continue to email listings and bring their listings to the office to post them on the bulletin board.

The relocation division has assigned and begun to prepare 39 relocation packages for the parcels which have been submitted to TXDOT for review and approval. During the month of January, a total 15 relocation packages have been approved. Relocation activities continue to consist of; preparing relocation packages, conducting inspections on comparable housing that will be used for establishing maximum relocation payments for residential households in the relocation packages and attending CAB meetings to answer questions.




