CUBA ADVOCACY GROUP LAUNCHES *ENGAGE CUBA TEXAS STATE COUNCIL* **~ Council includes key Texas business and industry leaders calling for an end to the travel and trade embargo ~**

AUSTIN, TX – Engage Cuba, a leading advocacy organization, today launched the *Engage Cuba Texas State Council* to build statewide support for Congressional action to end the travel ban and trade embargo on Cuba. The founding members of the Council include Texas leaders from a broad range of sectors including agriculture, business, technology, manufacturing, education, energy and health care. The Council seeks to expand trade with Cuba in order to provide economic and educational opportunities for the people of Texas, while empowering the Cuban people.

“Texas is a leading economic driver for the U.S. economy and opening up trade with Cuba would provide tremendous opportunities for businesses across the state. However, Texans are stuck on the sidelines as our foreign competitors continue to take advantage of Cuba’s growing markets,” **said James Williams, President of Engage Cuba.** “We are very pleased to have a diverse list of dynamic and engaged Texans willing to step up and call on Congress to lift the embargo that is costing Texas jobs and preventing economic development for the Cuban people. It’s time to end fifty years of failed isolationist policy towards Cuba.”

Cuba depends heavily on agricultural imports, which average two billion dollars annually, and this number will continue to grow given the increasing purchasing power of 11 million Cubans. There is also an immediate need for infrastructure improvements to meet the rising demand of foreign travelers. Texas is well positioned to help meet these and other needs on the island.

In addition to Texas, Engage Cuba has launched state councils in Georgia, Iowa, Minnesota, Ohio, Tennessee, Arkansas, and Louisiana. This [growing network of state councils](#) will mobilize grassroots support across the country for lifting the Cuban embargo.

Engage Cuba is advocating for three bills in Congress:

- The [Agricultural Export Expansion Act of 2015](#), which has six Texas co-sponsors, would allow American farmers to offer financing to Cuban importers and recapture lost market share.
- The [Freedom to Travel to Cuba Act](#) would expand Cuba's already growing markets and provide additional opportunities for U.S. agribusiness to export to Cuba. Bill text is available [here](#).
- The [Cuba Trade Act of 2015](#) would permit private-sector industries in the United States to export goods and services to Cuba. The bill includes language to ensure that U.S. taxpayers wouldn't be on the hook if the Cubans default on lines of credit extended by U.S. banks and businesses.
